If you become employed with the city, your social security number will be released to the Social Security Administration and Internal Revenue Service for payroll and tax purposes. You are not legally required to provide the information. Failure to provide may result in a delay in notifying you. This information is available only to the person the information is about, and anyone authorized by you or law to see it.

I authorize that my address and telephone number can be given to another election judge or school board election personnel for the sole purpose of contacting me to work for an election. I understand that my party designation is private and not released to outside groups. I waive my right to claim and hereby agree to hold harmless the City of Rogers and any of its agents or employees for any injury or damage which I may experience as a direct or indirect result of the intended use of this information.

I certify that the above information is accurate to the best of my ability. I also certify that:

- I am at least 18 years of age
- I am a citizen of the United States
- I can read, write, and speak English
- I am eligible to vote in Minnesota

Election judges may not serve at an election when his/her spouse, parent, child, or sibling is a candidate. In addition, an election judge may not serve in the same precinct with his/her spouse, parent, child, or sibling.
